Securing Precarious Worlds: Institutions, Catastrophic Risk, and the Emergent Politics of Survival

- My dissertation examines how global governance institutions respond to catastrophic risk (such as nuclear, environmental, and technological risk) by analyzing moments where dominant security frameworks break down or talk past alternative modes of understanding. It aims to map these points of friction in order to inform strategic foresight and decision-making, offering tools for navigating uncertainty and institutional deadlock in planetary governance.
